Dylai'r staff sicrhau fod ganddynt ddisgwyliadau uchel o safonau gwaith ac ymddygiad disgyblion.

INFORMATION FOR PARENTS

Parents



Parents must:

- Contact the School if you are aware of or have any concerns around behaviour.
- Encourage your child to follow school rules and procedures.
- Support the school with any further action.

Pupils



Pupils must:

- Follow School Rules
- Talk to staff and trust them to act on their behalf
- To be aware of the reward and sanctions used in school
- Accept their sanction if they have broken school/class rules

Governors



Governors must:

- Know and understand the policy
- Support staff to action the policy
- Complete their strategic role by reviewing the policy

School Staff



Staff should be aware of school rules and action them.

Staff should comply with Promoting Positive Behaviour recommendations by using praise and reward for good behaviour and sanctions when absolutely necessary.
Praise and reward should outweigh the number of sanctions.
More praise used, bad behaviour will be less.

Staff should steer away from sanctioning a whole group if possible and follow any problems through to the end.

Staff should have high expectations of behaviour and standard of work.

A log should be kept of any bad behaviour. Staff should be fair and consistent.

To be prepared to make time and listen to children and to take them seriously. Hold Circle Time.

Action the whole school policy in relation to rewards and sanctions.

Promote and encourage the desire in children to care for each other.

Set a good example by respecting children and adults ensuring the ethos is to co-operate and care for each other.

Work with parents.
